The Fiduciary responsibilities of board members.

How your Fiduciary duties affect your decisions as a Board member.

Every decision made by a board member that affects the association must follow all applicable bylaws, covenants and restrictions, and state laws that affect Homeowner associations.

Noncompliance with state statutes may result in board members personal liability and criminal prosecution.

Example

Radburn act

Failure to comply with regulations is considered a willful violation and a breach of Fiduciary duties and may, in certain circumstances, result in an election being invalidated with potential fines for which the board members might not be covered under standard directors' coverage.

Attorney obligation regarding compliance with State law.

Your board attorney must advise you when you are not in compliance with election requirements and the potential exposure as a board member to civil and criminal penalties.
